

Discussion

Dr. Sanjeev Padankatti asked what was the need for buying the second property of the AIOTA and if the original first property of the AIOTA has been put to use? He informed that consent of the GB was must for buying the second property of the AIOTA and asked if GB consent and approval was sought before buying the second property of the AIOTA.

Dr. Shashi Oberai answered that the first property has been used for the EC meetings of the AIOTA and ACOT and for academic activities of the ACOT. To cut down on the costs of hiring hotels or halls for meetings for EC members and as advised by the CA for financial reasons and as the property was available at the right time of the need of investment of the AIOTA on the same floor of the first property. So, it was decided to buy the second property during the EC meeting. Dr. Oberai answered that the second property was bought with the aim of conducting educational activities, skill development, as a centre for advanced learning and it was the right time to invest the AIOTA money for the property as we were getting a better offer for purchase.

Dr. Pratibha Vaidya informed that as advised by the CA to spend money as per 10B clause or else we had to pay that amount as a tax. Hence, utilizing the money for buying property was considered as the best option.

Dr. Satish Maslekar informed that the first property was bought in the year 2017 and inaugurated in the year 2018 with the GB meeting approval and that it was the approval for the overall property of the AIOTA and not specifically for 1st or 2nd property per se.

Dr. Gopal suggested to by group insurance for members of the AIOTA. Dr. Deepa S asked why the GB was not

called and why the information on buying the property was kept hidden from members of the AIOTA. Dr. Zarine

Ferzandi said that the decision was first to be informed in the GB and then to be bought. Dr. Shashi Oberai

informed that in the future AIOTA shall ask the GB. Dr. Vijay Batra suggested to help, support and strengthen

the branches. Dr. Yogita informed that she had approached the AIOTA for allowing the use of Headquarters for

members for educational activities/courses but the payment of rent expected by the AIOTA was too high. Dr.

Pankaj Kumar said that during COVID many OTs lost their lives and that the AIOTA should contribute to those

OTs.

Dr. Veena Slaich informed that AIOTA cannot fund branches and cannot fund other states as per the Bombay

Trust Act and that AIOTA can only consider 20% for giving it for other activities. Dr. Shanta Pandian informed

that members do not receive any information about AIOTA or ACOT activities. Dr. S. K. Meena informed all that

the AIOTA will discuss with the charity commissioner and get back to members. Dr. Pratibha Vaidya informed

that there limitations as per the Charity Commissioner's clause and that we are educational organization and that

if we had not invested the money, we would have lost it by paying it as tax. Dr. Koushik Sau asked for the Charity

Commissioners report. Dr. K Chelvan suggested to waive off the accreditation fees. Dr. Senthil Nath suggested

to have a plan for saving tax. Dr. Suresh requested that next time such financial matters to be informed to the GB

and to conduct courses in all states of the country. Dr. Jyothika Bijlani requested to send proposals for courses

for consideration. Dr. Sujata Missal to formulate a yearly calendar of events and inform the members about the

education activities.

Dr. Joseph Sunny informed that the AIOTA will consult the charity commissioner for investing the money in

different options other than buying the property and inform the members.

Ergonomic Certification Report by Dr. Shashi Oberai

AIOTA Ergonomic Inspection Report

It gives me great pleasure to present to you the AIOTA Ergonomic Inspection Certification Report.

AIOTA has been regularly receiving requests from Furniture Manufacturing Industries for Ergonomic Certification of their product ranges, and the AIOTA Ergonomic Inspection Committee headed by President Sir, Dr. A.K. Srivastava, has been promptly responding to them for both documentation as per AIOTA Guidelines and Certification Process. For your information, certificates are issued only after the compliance has been fulfilled by the organization.

Now I would like to submit the overall report from 2017 ever since AIOTA initiated the ergonomic certification process till 2022.

In 2017-18, AIOTA started with two companies and revenue collected was **Rs 1,50,000**/- plus Godrej payment of **Rs 83,000** /- was received for sponsorship and AIOTA certification fees.

In 2019 the total revenue collected was **Rs 6,75,000** /-. In 2020 total revenue collected was **Rs 20,46,875** /- In 2021 it came up to around **Rs 49,88,050** /-

Subsequently in 2022 total revenue collected was **Rs 75,67,977** /- adding up to approximate total collection till date amounts up to **Rs 1,55,11,202** /-

Around 40 + companies are registered with AIOTA and around 10 + are in the pipeline.

In the year 2022, 18 companies Renewed for Ergonomic Certification, 27 companies for New Registrations were added and 08 Companies were pending for Renewal.

I sincerely appreciate and thank our Hon. Treasurer Dr. Pratibha Vaidya for her regular and prompt support in coordinating with the financial transaction and for the sharing the financial details.

Special thanks to our President Sir, Dr. Anil Srivastava for his constant perseverance in planning and prompt decision at every step in this process.

Thanks to the Inspection Committee Members Dr. Satish Maslekar – Co-Convenor AIOTA Ergonomic Committee. Dr. Pratibha Vaidya and Dr. Neeraj Mishra, Committee Members, for their continued support.

I would like to thank Dr. Sunny Joseph, Hon. Secretary for promptly coordinating and Dr. Lakshmanan for managing the zoom meetings.

On behalf of President Sir and All Committee Members, I thank Vice President AIOTA- Dr. S.K. Meena, and all AIOTA EC Members for your trust and timely guidance.

Dr. Shashi Oberai informed that herself, Dr. Satish Maslekar, Dr. Pratibha Vaidya, Dr. Neeraj Mishra are part of the committee.

Dr. Shashi Oberai thereafter showed the members the video of the AIOTA property.

- 1. Proposed to modify the definition of Occupational therapy to include OT as a primary contact
- 2. Proposal to provide a softcopy of the WFOT membership certificate which is signed by both the WFOT and the member county
- 3. Affiliation of MOT

Dean ACOT Report

Report

1) Accreditation of BOT & MOT Programs of OT Colleges

- a. BOT program of JSS OT college in Mysuru has been provisionally accredited from January 2023 to
 December 2024 after reviewing their compliance report submitted on 29th January 2023
- b. MG OT College & Saveetha OT College have completed their term of temporary accreditation in July & Oct respectively. We need to carry out physical inspection of MG OT College, Saveetha OT College & Sri Ramchandra College of OT (in February 2023) as per AIOTA's policy.
- c. October/November 2023 Report

2. Camp II. Elders' Fall Prevention Camp was organized at Bramha Samaj Anand Ashram, Nerul, Navi Mumbai. Simple assessments like coordination test and Rhomberg's test were performed on them. 




