Responsibilities of the Committee:

The committee shall:

1. Supervise the up-dation of the voter list of TNAIOTA members.
2. Ensure fairness and transparency in the process.
3. Monitor that no application of an eligible Occupational Therapist (OT) is rejected for membership and inclusion in the voter list without valid reason.
4. The up-dation and membership program will continue for 15 days from the date of issue of this order, which is till 10<sup>th</sup> of March 2025.
5. After completion of the 15-day period, the signed (by Member Secretary) updated voter list of TNAIOTA members shall be handed over to the President, AIOTA, to initiate the election process.

Qualified Occupational Therapists in Tamil Nadu may apply, based on their eligibility, to become members of the TNAIOTA branch of AIOTA and be included in the voters' list.

The members shall also coordinate effectively and carry out their responsibilities with diligence.
