REGISTRATION & CERTIFICATION

- Registration: Non-refundable one time Registration fee for AIOTA Certification is INR 59,000.00 (Including 18% GST)
 Registration Form: may also be downloaded from AIOTA Website <u>www.aiota.org</u>
 Minimum 5 years in Manufacturing of Furniture is essential for registration.
- 2. Inspection Fee: INR30,000 for each specified range of furniture.
- 3. Certification Fee: As per required Ranges of Furniture. Fee structure for certification is given below in <u>Table 1.</u>
- 4. Certification and Validity Period: The certificate will only be issued after the satisfactory report by the duly appointed 2 members Inspection Committee. Validity Period: <u>The certificate issued for the first time will have validity period of one year.</u>
- 5. **Documentation:** The required documents specified in the Request Form should be sent along with Registration Fee in soft copy first to <u>president@aiota.org</u> with copy to convener, EDCC <u>vicepresident@aiota.org</u>
- 6. Certification and Inspection Fee should only be sent after verification of the submitted documents.
- 7. CA Certificate: It would be mandatory to submit Certification of last three financial years issued by authorized CA (Chartered Accountant).
- 8. All the travel expenses (To & Fro airfare) and hospitality to the inspection team (Max. two persons) shall be borne by the applying firm.
- 9. The certificate shall be issued in the name of firm as registered with the AIOTA. The name of the firm shall not be changed in the certificates or renewed certificate (s) in future. In case the firm wishes to change the name, it shall have to apply and register a fresh with AIOTA with new name of firm as a new case.
- *10.* Once registered with the AIOTA, it is deemed that the firm has understood the regulations for AIOTA Ergonomic Design and Performance Certification well and shall abide by the decision of AIOTA.

Timeline for Ergonomic Design Certification:

- a) Response Time for Certification Requests: Upon receiving a request for ergonomic certification, a designated time frame should be established within which the initial response should be sent to the applicant 03 working days max.
- b) Client Response Time: After sending the ergonomic certification guidelines, forms, and regulations to the aspiring member, there should be a clearly defined turnaround time for the client to respond with the necessary documents and the initial registration fee 10 working days max
- c) Confirmation of Payment and Documents: Once the registration fee has been credited to the AIOTA bank account and confirmed, the respective members should inform the Secretary's office of the document receipt and fee credited information within a specified time frame:
 03 working days max
- d) Inspection Scheduling: After completing the registration screening, an inspection team will be set and the time frame for completion of the inspection will be : **30 working days max**.
- e) Post-Inspection Modifications: Any required modifications or updates following the inspection should be completed within a specific time frame. The client must inform AIOTA once these changes are made so that the certification issuance process can be initiated promptly - 25 working days max
- f) QR Code and Certification Generation: Upon completing the inspection, a time frame should be communicated to the client for generating the QR code and issuing the certification - 07 working days max.
